## **Search for Breasia Terrell Moves to Clinton County**

*New information leads investigators to Clinton County, over 10 agencies supporting the search.*

DAVENPORT, IOWA (July 16, 2020 | 11:00 AM) - The search in the missing persons case of Breasia Terrell has moved to Clinton County after new information was obtained. The Davenport Police Department is currently partnering with several local agencies in the search as of Thursday morning. Partner agencies include Bettendorf Police, Scott County Sheriff, Clinton County Sheriff, Camanche Police, Clinton Police, Iowa Department of Criminal Investigation, Scott County Emergency Management, Clinton County Emergency Management, Clinton County CERT, Iowa USAR and the FBI. The search includes aerial support provided by Iowa State Patrol and Clinton Police. The Center for Missing and Exploited Children continues to support the Davenport Police Department in this case.

On Tuesday July 14, the Davenport Police Department named Henry E. Dinkins as a person of interest in the Breasia Terrell case. The Davenport Police Department continues to ask the public for any information regarding Dinkins whereabouts from 10pm on Thursday, July 9 to 12pm on Friday, July 10. Dinkins' primary vehicle is believed to be the 2007 Maroon Chevy Impala. Anyone with information is asked to call 563-326-6125.

An Amber Alert was issued for Breasia Terrell on July 15 and remains in effect.

Scott County and Clinton County Emergency Management Agencies are coordinating volunteers who would like to participate in the search in Clinton County. Volunteers are asked to report to Low Moor Community Center to check in and be provided more information regarding the search.

The Davenport Police Department is working with Family Resources' Survivor Services Department to ensure all resources and referrals are
