## USING THE DAVENPORT COMPOST FACILITY FOR YARD AND WOOD WASTE DISPOSAL

- **Check-in at our drive-up window. All loads must receive prior approval.**
- **Have your ID and form of payment ready.**
- **Pay applicable fees and follow direction provided for disposal.**
- **Deposit material as instructed. Materials must be emptied and removed from plastic bags by the customer. Plastic bags are not compostable and not accepted with disposal.**



### PREPARE MATERIAL FOR DROP-OFF

- *Consider kraft-ply bags for transport instead of plastic. If material is placed in a plastic bag, the material will need to be emptied from the bag during disposal and the bag disposed of off-site.*
- *Branches and logs longer than five feet are not accepted. If your material is over five feet in length, reduce the length of material to less than five feet to allow for drop-off.*
- *Know what other materials we cannot accept.*

### RESIDENTIAL DROP OFF FEES

- **There are no fees for trees, branches, limbs, woody bush material, tree logs and wood chips from stump grinding. Just remember, material longer than five feet cannot be accepted.**
- **A fee of \$.50 per container or \$6.00 per cubic yard applies to all materials being dropped off.**

### ACCEPTED MATERIAL

- Acorns
- Apples
- Branches
- Clean Tree Root Balls
- Flowers
- Garden Debris
- Grass
- Hedge/Bush Trimmings
- Leaves
- Logs
- Pine Needles
- Plants
- Pumpkins
- Straw/Hay
- Tree Trimmings
- Walnuts
- Weeds (not Noxious or Invasive)
- Stump Grindings

### NOT ACCEPTED

- Any material over 5 FT in length
- Building/Construction Debris
- Concrete
- Dirt
- Dirt Covered Tree Root Balls
- Fence Posts
- Garbage
- Invasive and Noxious Weeds\*
- Landscaping Timbers
- Lumber
- Metal
- Mulch
- Plastic
- Plastics
- Railroad Ties
- Rocks
- Sod
- Tires



There are a number of materials we cannot accept due to regulatory requirements, processing needs and capabilities, and to ensure our ability to produce high-quality natural compost, soil and landscaping products.
